High School Registration Process

Registration is a seven step process. All players, and referees must be members of the Roller Hockey Alliance (RHA).

Step 1: Register with Shoot Out Sports

Go to www.shootoutsports.com to register today.

Step 2: Ensure all players and coaches are RHA Members

We have included a copy of the RHA membership Form. Shoot Out Sports cannot accept RHA membership forms.

Step 3: Have a completed Shoot Out Sports Release and Waiver Form for each player

We have included a copy of the waiver form. These forms must be turned in prior to your teams first game.

Step 4: Pay your teams remaining balance on or before the deadline.

Step 5: Complete your teams roster online

After the deadline all teams will receive a username and password to the secure area of the Shoot Out Sports Website. Here you will be able to complete your teams roster. Any player with missing information is considered ineligible and will not be allowed to play.

Note: You will be allowed to make changes to the roster up to the third game of the season. After which your roster will be "frozen" and no more changes will be allowed.

Step 6: Schedules will be posted online.

Step 7: Arrive 45 minutes prior to your first game

You will be required to:

- a. Turn in all Shoot Out Sports Release and Waiver Forms.
- b. Bring in a copy of each players school ID.

SHOOT OUT SPORTS

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY

IN CONSIDERATION of being permitted to participate in any way in Shoot Out Sports Activities ("Activity") I, for myself for personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree, and represent that I understand the nature of Shoot Out Sports Activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further agree and warrant that if at anytime I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.

2. FULLY UNDERSTAND THAT: (a) SHOOT OUT SPORTS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by my own actions or inaction's, the actions or inaction's of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISK AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation or that of the minor in the Activity.

3. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE SHOOT OUT SPORTS AND ITS AFFILIATES, their respective administrators, directors, agents, officers, members, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owner and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.

Waiver of Liability, Release Assumption of Risk and Indemnity Agreement

It is the purpose of this agreement to exempt, waive, and relieve releasees from liability for personal injury, property damage, and wrongful death, including if caused by negligence, including the negligence, if any, of releasees. "Releasees" include the Roller Hockey Alliance (RHA), its affiliate associations, local associations, member teams, event hosts, other participants, coaches, officials, sponsors, advertisers, and each of them, their officers, directors, agents and employees.

For and in consideration of the undersigned participant's registration with the Roller Hockey Alliance, its affiliates, local associations and member teams (all referred together as RHA) and being allowed to participate in RHA events and member team activities, participant (and the parent(s) or legal guardian(s) of participant, if applicable) waive, release and relinquish any and all claims for liability and cause(s) of action, including for personal injury, property damage or wrongful death occurring to participant, arising out of participation in RHA events, member team activities, the sport of roller hockey, and/or activities incidental thereto, whenever or how ever they occur and for such period said activities may continue, and by this agreement any such claims, rights, and causes of action that participant (and participant's parent(s) or legal guardian(s), if applicable) may have are hereby waived, released, and relinquished, and participant (and participant's parent(s) or legal guardian(s), if applicable) does/do so on behalf of my/our and participant's heirs, executors, administrators, and assigns.

Participant (and participant's parent(s)/guardian(s), if applicable) acknowledge, understand and assume all risks relating to roller hockey and any member team activities, and understand that roller hockey and member team activities involve risks to participant's person including bodily injury, partial or total disability, paralysis and death, and damages which may arise therefrom and that I/we have full knowledge of said risks. These risks and dangers may be caused by negligence of the participant or the negligence of others, including the "releasees" identified below. These risks and dangers include, but are not limited to, those arising from participating with bigger, faster and stronger opponents and these risks and dangers will increase if participant participates in roller hockey and member team activities in and age group above that which participant would normally participate in. I/We further acknowledge that there may be risks and dangers not known to us or not reasonably foreseeable at this time. Participant (and participant's parent(s)/guardian(s), if applicable) acknowledge, understand and agree all of the risks and dangers described throughout this agreement, including those caused by the negligence of participant and/or others, are included within this waiver, release and relinquishment described in the preceding paragraph. I/We agree to abide by and be bound under the rules of the RHA, including the By-Laws of the corporation and the arbitration clause provisions, as currently published. Copies are available to RHA members upon written request.

Participant (and participant's parent(s)/legal guardian(s), if applicable) acknowledge, understand and assume the risks, if any, arising from the conditions and use of roller hockey rinks and related premises and acknowledge and understand that included within the scope of this waiver and release is any cause of action (including any cause of action based on negligence) arising from the performance, or failure to perform, maintenance, inspection, supervision or control of said areas and for the failure to warn of dangerous conditions existing at said rinks for negligent selection of certain releasees, or negligent supervision or instruction by releasees.

If the law in any controlling jurisdiction renders any part of this agreement unenforceable, the remainder of this agreement shall nevertheless remain enforceable to the full extent, if any, allowed by controlling law. This agreement affects your legal rights, and you may wish to consult an attorney concerning this agreement.

Participant (and participant's parent(s)/legal guardian(s), if applicable) agree if any claim for participant's personal injury or wrongful death is commenced against releasees, he/she shall defend, indemnify and save harmless releasees from any and all claims or causes of action by whomever or whatever made or presented for participant's personal injuries, property damage or wrongful death.

Participant (and participant's parent(s)/legal guardian(s), if applicable) acknowledge that they have been provided and have read the above paragraphs and have not relied upon any representation or releases, that they are fully advised of the potential dangers of roller hockey and understand these waivers and releases are necessary to allow amateur roller hockey to exist in its present form. Significant exclusions may apply to the Roller Hockey Alliance's insurance policies, which could affect any coverage. For example, there is not liability coverage for claims of one player against another player. Read your brochure carefully and, if you have any questions, contact a RHA administrator.
