DIVISIONS	Junior Varsity (8 th – 11 th grade), and Varsity (9 th – 12 th grade)	
PLAYER ELIGIBILITY	Every player must be a member of the Roller Hockey Alliance, complete a Shoot out Sports release of liability, attend the school of the team they are playing for, and submit a copy of their current school ID or report card.	
PLAY	All teams are guaranteed a minimum of three games. Games will have three (3) fourteen (14) minutes periods.	
PLAYING RULES	All games will be played by the Shoot Out Sports Rule Book. -Each team is required to be dresses and ready to play 30 minutes prior to the start of its game. -During round robin play no games will have an overtime period. -An eight (8) goal “mercy” rule will be in effect. -Teams will be awarded two (2) points for a win, one (1) for a tie, and zero (0) points for a loss. -Tie-Breaker rules for advancement to the playoff/championship games: <ol style="list-style-type: none">1. Head-to-Head competition2. Goal Differential in Head to Head contest3. Overall Total Lowest Goals Against4. Overall Total Highest Goals For5. 4-Player Shoot-Out -All ties in a playoff or championship games will have one – five minute sudden-death period. This will be followed by a 4-player shoot-out and if necessary a sudden-death shoot-out.	
ENTRY FEE	Team deadline for team entry fee of \$425.00 is May 5, 2010. Teams attempting to register after May 5 must pay \$475.00. Registration fees are non-refundable. All checks/M.O.’s should be made payable to Shoot Out Sports.

RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY

IN CONSIDERATION of being permitted to participate in any way in Shoot Out Sports Activities ("Activity") I, for myself for personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree, and represent that I understand the nature of Shoot Out Sports Activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further agree and warrant that if at anytime I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.

2. FULLY UNDERSTAND THAT: (a) SHOOT OUT SPORTS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by my own actions or inaction's, the actions or inaction's of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISK AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation or that of the minor in the Activity.

3. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE SHOOT OUT SPORTS AND ITS AFFILIATES, their respective administrators, directors, agents, officers, members, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owner and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I, or anyone on my behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT AND HAVE SIGNED IT FREELY AND WITHOUT INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.
